Dear 8th Grade Parents,

Thank you for your overwhelmingly positive response to our Disney trip proposal. The trip has been approved by Fulton County Schools and the Northwestern administration, so we are moving forward! We have applied to perform for Disney Performing Arts and will have an itinerary for you as soon as possible.

We would like to assure you that your child's safety while traveling is our first concern. We have had a great deal of experience with performing groups on overnight trips and there will also be certified chaperones monitoring the students. Students are never left unsupervised in the hotel. The Disney parks are very safe for teenagers; students will be supervised by chaperones in the parks and there will be open cell phone communication between directors, students, and chaperones. Students will be required to abide by all Northwestern and Fulton County policies on this trip, including use of language, personal displays of affection, and the dress code. Students who do not abide by the rules or who are late to meeting points will lose time in the parks or will receive the same disciplinary consequences as if we were in school. The behavior expectations will be reviewed extensively with students before the trip and will be published with the other trip documents. We also plan to have a parent meeting before the trip. In order to keep our trip supervision closely monitored, students who travel on this trip with us are required to stay with our group exclusively, and with their assigned chaperone, and may not spend time with other friends or relatives while we are in Florida. If you have questions about this expectation, please talk with your director.

The trip dates are March 8-12, 2017. Friday, March 10th is a teacher workday, so students will only miss 1.5 days of school as we will leave at noon on Wednesday, March 8. Students must bring luggage to school on Wednesday morning before school. We will leave the park at closing on Saturday night, then drive through the night and return to NMS very early Sunday morning. Monday, March 13 is also a holiday for students. This trip will include 3 days in the parks with meal vouchers, 3 nights in a hotel, breakfast at the hotel, chartered buses and a performance.

The cost for the trip is \$550.00 per student, which includes transportation on a charter bus equipped with a bathroom, televisions with DVD, 3 nights lodging, 3 days admission to Disney World parks, 3 Disney meal vouchers, and a breakfast buffet for three mornings. Students will need some spending money for souvenirs and additional meals. Students will be housed 4 to a room. Hotel information will be published shortly before the trip.

The cost for parent chaperones is \$550 for double occupancy (there is an additional \$95 single occupancy room charge). Chaperones will be selected based on previous volunteer service, student needs, and available space on the trip. Please indicate on the return form if you are interested in chaperoning this trip, but keep in mind that as a chaperone you are expected to travel exclusively with our group which includes riding the bus with students, monitoring students on the bus, at rest stops or food stops, in the hotel and in the parks. Chaperones will have to go through the Fulton County volunteer badging process that includes a background check and fingerprinting (not the same as the school volunteer or chaperone). But of course you will have a lot of fun watching our fabulous performances and enjoying the parks! As soon as we receive your request to chaperone on the commitment form, we will email a confirmation to you with payment details.

We are only accepting online payments through the website for this trip. The first trip payment of \$300 per person is due by Friday, December 2nd at midnight. This will include a \$300 deposit for accepted parent chaperones. You also have the option to pay the entire \$550 amount at this time. When you send in your signed commitment form, we will email you the payment link with further instructions. The final payment of \$250 will be due January 13th.

However, trip insurance is available to you to purchase individually through **CSA Travel Protection** at www.csatravelprotection.com for an additional fee which is paid directly to **CSA Travel Protection**. By signing below you agree to purchase the trip insurance on your own or to hold Creative Group Tours, the Fulton County School District, Northwestern Middle School, and the Chorus and Orchestra director(s) harmless for cancellation due to severe weather or natural disaster, extreme illness or injury, death in the family, national crisis, or any other unforeseen circumstances or event that prevents the trip from taking place. The Fulton County School District, Northwestern Chorus and Orchestra Directors, Creative Group Tours, or Northwestern Middle School will not refund the cost of the trip if you are unable to attend for ANY reason, including an unavoidable schedule conflict, death in your family, injury or illness that prevents your child from traveling, or severe disciplinary infraction that prohibits your child from traveling with the group (Fulton County Policy). If you purchase the trip insurance, you would be responsible for filing a claim with the trip insurance company in the event your child cannot go on the trip. Please be aware that all circumstances may not be covered by the trip insurance.
